

Emissions reduction targets

In order to continue our progress to achieving Net Zero the global parent company DXC Technology has adopted a carbon reduction target of 55% by FY25. Luxoft UK contributes to this target and we project that carbon emissions will decrease to 345 tCO2e by FY25. This is a reduction of 25% compared with the baseline. Progress against these targets can be seen in the graph below:



Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2018-19 baseline. The cumulative carbon emission reduction achieved by these schemes and additional minor changes to date equates to 100 tCO2e, a 40% reduction against the 2018-19 baseline and the measures will be in effect when performing the contract:

Adopting a Virtual First approach: Closure of one of the office locations, encouraging flexible working for employees and cutting commuting emissions.	54	12%
Reduced business travel and use of fleet vehicles.	5	1%

In the future we plan to implement further measures such as:

- Further energy efficiency improvements to Welwyn Garden City office
- Engagement with key suppliers to address emissions within the value chain
- Circular economy approach to reduce waste.
