

Emissions reduction targets

In order to continue our progress to achieving Net Zero the global parent company DXC Technology has adopted a carbon reduction target of 55% by FY25. eBECS Limited contributes to this target and we project that carbon emissions will remain below 266 tCO2e to FY25. This is a reduction of 25% compared with the baseline. Progress against these targets can be seen in the graph below:



Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2018-19 baseline. The cumulative carbon emission reduction achieved by these schemes and additional minor changes to date equates to 90 tCO2e, a 25% reduction against the 2018-19 baseline and the measures will be in effect when performing the contract:

In the future we plan to implement further measures such as:

- Further realisation (full year effect) of savings from site closures
- Engagement with key suppliers to address emissions within the value chain
